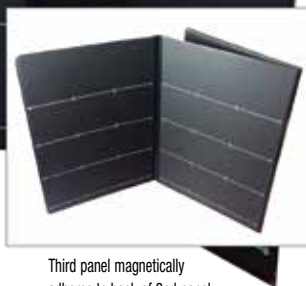


# The Jury Case® “Your Voir Dire Organizer”

The Jury Case is the Voir Dire Organizer for the bench and the bar that makes jury selection more efficient, keeps the attorney connected to the jury during trial and aids in the formulation of the closing argument.

The Jury Case opens to display a 32" x 15" jury selection grid across the 3 panels. It holds self-adhesive notes (“Juror Tags”) lined to record pertinent information for use in the jury selection process. Each juror’s seat number is prominently displayed on the upper right corner of the tags. Shift the tags around the grid as jurors are excused for cause and by peremptory challenge.

A Peremptory Tag keeps track of the challenges made by both sides. The grid duplicates a “6 Pack” or “9 Pack” seating arrangement; it adapts to other arrangements used by the court such as 7 jurors in the first two rows. 36 Juror Tags fit on the grid. The Panel Cards hold an additional 60 Juror Tags for large venires. This system works for judges, jury consultants, plaintiff and defendant attorneys, prosecution and accused.
