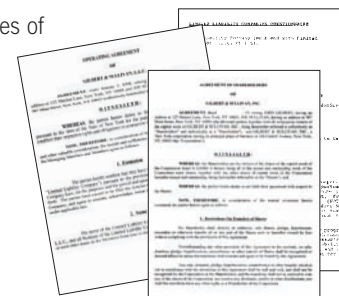
Registered Agent Services

Texas statutes require that all corporations, limited partnerships, limited liability companies, and foreign entities maintain within the State of Texas a Registered Agent for Service. This person or entity must be designated in all formation documents and any changes must be filed with the Texas Secretary of State. **BlumbergExcelsior Corporate Services, Inc.** will act as the Registered Agent for any corporation or other entity on a yearly basis and will accept and forward all documents immediately.
