NOTE: In response to the "fiscal cliff" Congress passed the "American Taxpayer Relief Act of 2012." That Act set the estate tax at $40 \%$ on estates over $\$ 5,000,000$ (indexed for inflation). It also deleted the 12/31/2012 "sunset provisions" from the Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010 and the Economic Growth and Tax Relief Reconciliation Act of 2001 so that unification of the estate tax exclusion amount, gift tax exemption and GST exemption will continue at $\$ 5,000,000$, subject to indexing, until further legislation. And the estate tax exclusion amount will continue to be "portable"; the basic exclusion amount of a surviving spouse may be increased by the unused exclusion amount of the deceased spouse, letting a couple exclude $\$ 10,000,000$ from the federal estate tax, without having to use a credit shelter trust.
Estate planners now might be entering a period of relative stability in contrast to the somewhat chaotic legal structure experienced since 2001. However, future legislation may again change the federal tax laws, and the new laws have yet to be judicially or administratively interpreted. Also state estate and inheritance laws have been and will continue to be
